Principal's Report

- Staffing for 2021/22- back to 12 divisions. People are moving into the neighborhood. There is hiring for teacher librarian, kindergarten teacher, LA/RT teacher and grade 5 teacher. Mrs. Hayes will be continuing in her position for Math for the following year, so a teacher will be placed for her position
